INFORMATION SHEET

1. The crucial date for determining the age limit of the candidate will be the closing date for receipt of applications. The last date for receipt of the application is 30 days from the date of publication of this advertisement in the employment news (to be calculated from the starting date of publication).
2. The candidates are required to submit attested copies of certificates in support of their claims regarding age, educational qualifications, SC/ST/OBC/PH etc. along with their application.
3. Mere eligibility will not vest any right on any candidate for being called for written test/ interview. The decision of the competent authority in CARD in all matters will be final. No correspondence will be entertained from the candidates in connection with the process of selection/ written test /interview etc. Canvassing in any manner would entail disqualification of the candidature.
4. The candidates apply for the posts as notified should ensure that they fulfil all the prescribed eligibility conditions as on the closing date for receipt of applications.
5. The Director, CARD has the right to fix criteria for screening the application so as to reduce the number of candidates to be called for written test / interview.
6. Application fee of Rs.500/- for the post of Assistant and Rs. 300/- for the post of Skilled Support Staff (non-refundable) in the form of demand draft drawn in favour of ICAR-Krishi Vigyan Kendra, payable at SBI, Kumbanad should be enclosed along with the application. No other means of payment will be accepted. No fee for SC/ ST/ woman candidates.

8. Those already in government service (Central/ state/ autonomous bodies) should forward their application through proper channel.
9. Incomplete applications or applications without latest photograph, signature, attested copies of certificates and applications received after the last date are liable to be rejected.
10. When called for written test/ interview the candidate will have to appear at a place and no TA/DA will be paid.
11. Applications received after due date for whatsoever reason including postal delay will not be considered.
